### What is the 16-19 Bursary Fund?

The 16 to 19 Bursary Fund provides financial support to help students overcome specific financial barriers to participation so they can remain in education. You can apply for one of two bursaries:

- ➤ **Enhanced Bursary Fund** Government funding for young people in one of four defined vulnerable groups:
  - o in care
  - o care leavers
  - o receiving Income Support, or Universal Credit because they are financially supporting themselves or financially supporting themselves and someone who is dependent on them and living with them such as a child or partner
  - o receiving Disability Living Allowance or Personal Independence Payments in their own right as well as Employment and Support Allowance or Universal Credit in their own right
- Discretionary Bursary Fund Government funding awarded by the college to meet individual learner's needs

The bursary is paid to enable you to remain in education and funding is subject to good attendance.

#### Who can apply?

To apply for one of these bursaries you must:

- meet the ESF Agency residency criteria (see bursary guidelines)
- be aged 16 or over but under 19 at 31 August 2025 (If you turn 19 during your course of study, you will still receive funding until the end of the academic year)
- be aged 19 or over at 31 August 2025 and have an Education, Health and Care Plan (Discretionary Bursary only)

# Section three - Enhanced Bursary Fund (known as Defined Vulnerable groups bursary)

You may be eligible for an Enhanced Bursary of up to £1200 a year if you fall into any of the defined vulnerable groups. This bursary can be used to contribute towards travel costs, college meals, uniform, course materials and books — funding will be prioritised towards these expenditures. If funding is available and notice has been given and the beginning of the academic year, the school may contribute towards the cost of compulsory educational trips. Students on full time courses can receive up to £1200 calculated on an individual needs basis, students on part time courses will receive a pro-rata amount. ### **Section four - Discretionary Bursary Scheme**

You may be eligible for a Discretionary Bursary if you or your family have a household income of below £25,000. This bursary can be used to contribute towards travel costs, school meals, uniform, course materials and books (including whilst on industry placement) – funding will be prioritised towards these expenditures. If funding is available and notice has been given and the beginning of the academic year, the college may contribute towards the cost of compulsory educational trips.
