New Annual Review Letter - template

Local authorities have a legal duty to review and amend an EHC plan when a child or young person transfers from one phase of education to another. For example, from primary to secondary school, or from secondary school to a post-16 institution.

Discussions about transfer need to begin early in the autumn term of the year before transfer to allow plenty of time for the review and amendment process to happen.

All children of compulsory school age are legally entitled to receive a suitable

full-time education. Schools cannot place children on a part-time timetable, save in exceptional circumstances to meet a pupil's individual needs.
